THE SENIOR MINISTER MINISTER OF COMMERCE

- Pursuant to the Constitution of the Kingdom of Cambodia;

 Pursuant to the Preah Reach Kram No 02/NS/94 dated July 20, 1994 on the Organization and Functioning of the Council of Ministers;

- Pursuant to the Royal Decree No NS/RK/0704/124 dated July 15, 2004 on the Appointment of the Royal Government of Cambodia;

- Pursuant to the Preah Reach Kram No SN/RK/ 0196/16 dated January 24, 1996 on the Creation of the Ministry of Commerce;

- Pursuant to the Sub-Decree No 54 AK dated September 22, 1997 on the Organization and Functioning of the Ministry of Commerce;

Seen the needs of the Ministry;

DECIDES

Article 1: To consider as temporarily closed the garment factory of MIGHTI-SPECTRA KNITTING FACTORY LTD. which was temporarily inactive for various reasons but whose production facilities, equipment and machinery are kept intact and whose workers were temporarily laid off:

This factory would be de-registered from the MFN/GSP List of Eligible Exporters at the Trade Preferences Department. The eligibility of the said factory would be restored if it resumes its activities within the next four months. If it were not resuming its activities in the next four months, its registration at the Ministry of Commerce's Commercial Register would be then struck in red and annotated as "closed".

Article 2: Further investigations shall be undertaken by the Trade Preferences Department, the Foreign Trade Department, the

The Director General for Technical Affairs, the Director of the Senior Minister's Cabinet, the Director of Trade Preferences Department, the Director of Foreign Trade Department, the Director of Asean and International Organization Department, the Director of Cambodia Import-Export Inspection and Fraud Repression Department, the Director of Legal Affairs Department and the company whose name appears in Article 1 shall implement this PRAKAS from the date of its signing.
